November 20, 2017

The meeting was called to order at 7:05 PM with a quorum declared.

Margaret lit the Christ candle. Rev. Havlik talked about the best way and things you need for a church, which is people who loves Jesus. People that are there to love each other and are willing to share the good news with other people. Joys and concerns were shared. Pastor Helen gave the opening prayer.

Additions to the agenda: Under unfinished business, a pastoral search update will be discussed.

Minutes: The October 16, 2017 minutes were reviewed. **There was a motion and a second to approve the minutes. All were in favor. The motion passed. The minutes of the special session meeting on October 16, 2017 were reviewed. There was a motion and a second to approve these minutes. All were in favor. The motion passed.**

clerk's Report:

Communion was served on October 1, 2017.

On October 17th, Evelyn and Margaret attended the "Pruning the Vine" meeting at Forest Hill Presbyterian Church in Grand Rapids. Rev. Havlik chaired this meeting and explained that 9 gatherings were being held in various churches in September and October. She ask "What are the most important things that Presbytery can do for congregations" and "What should they focus on". The meetings have a lot to do with communication. Ways for Presbytery to connect and share things. A lot of people would like some training opportunities as well as ways of connecting people and congregations. A summary form of the meetings will be available at the next Presbytery meeting December 5th.

A report of the Ionia Ministerial Association's meeting November 2, 2017 was e-mail to the church. Restore Church had a community Thanksgiving Service November 19 at their church. There was a discussion about how to maintain security during church services. Restore Church is happy to share their protocols. Margaret will contact them.

The Friends of Jesus fund report was reviewed. All agreed the number of help calls has increased, especially for homeless individuals and families. There is some indication that Have Mercy may be purchasing the old Friend of the Court building and turning it into a homeless shelter. The Advent Walk this year is December 10th at 6PM starting at the First Christian Church.

Recorded the November 18, 2017 death of member #159, Nancy Nichols. Dr. Chris Dorn officiated at her funeral/memorial service November 25th at 3PM in the church sanctuary. There were drinks and cookies immediately following the service in the fellowship hall.

Action Item:

Approve the 2017 Clerk's Questionnaire

Because the questionnaire was 67 questions and 29 pages long, it was not copied for any of the session members. Via e-mail, a blank questionnaire was sent to session members; however, there was no way to complete the answers on-line without submitting it. It was discussed at the meeting. **A motion was made to approve the 2017 Clerk's Questionnaire. There was a second. The motion passed.**

Approve First Presbyterian participating in the Advent Walk on December 10th. **There was a motion and a second for our church to participate in the Advent Walk. As they have in the past, the Harkness Bell Choir will be playing. As yet, we have not received information from the coordinator, Adam Rewa, of the SSPP church. All were in favor. The motion passed.**

The Membership and Care Committee is recommending Cheryl Kidle's membership be transferred to the Coldwater First Presbyterian Church. Her transfer form was signed by Rev. Havlik at the October session meeting and sent to the Coldwater church the following day. The official register reflects she has transferred her member and is no longer an active member of our church.

Under new business, see item a. An October 25, 2017 letter was received from the City of Ionia and indicates the Downtown Development Authority plans to wrap the historic lampposts with fresh garland. The cost is \$20 per lamppost. One of the lampposts in front of our church already has garland and was sponsored by the new bakery downtown.

REPORTS OF STANDING COMMITTEES:

Please report only the information that the whole Session needs to hear.

Budget and Finance: Lavonna Hoover, Chairperson, provided the financial Balance Sheet along with the Profit and Loss Budget Vs Actual. She said we are doing OK. A question was asked about the General Fund Checking Account and the Memorial Funds #1055 Due from the General Fund. Lavonna explained the church only has one checking account. Therefore, the memorial money is in this checking account and that amount is \$65,000.00, which is memorial money.

Building and Grounds:

Dr. Warren Thompson, Co-chairperson, submitted a third quarter written report at our last meeting. There was nothing new to report.

Christian Education:

Judi Emlinger, Chairperson, submitted the March, May, August, September, October, and November reports from the meetings. Marcia Kohloff has joined this committee. The committee sponsored coffee fellowship September 17, October 29, and November 19th. The student outing in November was to Anderson Girls Orchard north of Stanton. Everyone attending had a great time. The committee has been planning the activities for the children at each of our family nights.

Membership and Care:

Margaret Gregory, Co-chairperson, reported that at the November 8th meeting the rolls were reviewed. The recommendation is to update the official roll register book to reflect that Cheryl Kidle's membership has been transferred to the First Presbyterian Church in Coldwater. The following membership have not been active nor have they contributed financially in over two years: Diane Barnes, and Frederick Fuhrman. Marley Marrs has moved to an adult foster home in Riverdale. The committee is recommending all three members be placed on the inactive rolls.

A motion was made to place Diane Barnes, Fred Fuhrman and Marley Marrs on the inactive rolls and transfer Cheryl Kidle's membership. There was a second. All were in favor. The motion carried. Additionally, Nancy Nichols died on November 18, 2017 and has been removed from the active membership rolls. With this review, there are 69 active members. The committee continues to send birthday cards, get well cards, sympathy cards and thinking of you cards. The committee will also be hosting coffee fellowship in December.

Personnel:

Keith Sterner, Chairperson, reported the committee met and discussed the annual employee reviews for Mike Kauffman, Steve Slaughter and Deb Montgomery. The committee met with Deb the same day for her review. Her review was satisfactory. When asked what would make her job easier, she stated having a pastor. For Christmas, the committee is recommending a \$50 gift card for each of our three employees. **A motion was made to purchase a Meijer gift card in the amount of \$50 for each employee. There was a second. A suggestion was made to also compensate Cindy Rozich for all her work as the hand bell choir director. While she is appreciative of the offer, she declined. All were in favor. The motion passed.** Steve and Mike's review will be scheduled soon.

Stewardship:

Margaret informed the session that Barb Klink has provided her with a draft copy of a possible stewardship letter to mail to the congregation. Barb also provided a copy of the 2017 letter that was sent for the last stewardship drive. She has said she and Lee are willing to help; however, she requested someone on the session chair this committee.

Warren made the suggestion to wait until after the holiday season, and that we maintain the current budget. Then, base the budget on the year-end figures. Lavonna was in agreement with this. Therefore, the stewardship letter was placed on hold. No one volunteer to chair this committee.

Worship:

Kathy VanSyckle, Chairperson, has been scheduling pulpit supply. Rev. Dr. Barbara Edema was scheduled to preach October 29 and November 5th; however, she had to cancel due to a crisis at the First Presbyterian Church in downtown Lansing, where she and her husband attend. Their pastor, Rev. Jenkins, is in the hospital, and she has felt it necessary to fill their pulpit. Kathy made arrangements with Dr. Chris Dorn to fill our pulpit through the end of the year. Kathy stated the only date he was not available was Sunday December 24. She said for the morning service there will be a Christmas pageant, and we will not need a pastor. This leaves Christmas Eve without scheduled pulpit supply. Kathy, Warren, Keith and Margaret, as the small pastor search committee, had discussed not scheduling a Christmas Eve service this year. While it has been our tradition to have a Christmas Eve candle lightening worship service without a pastor, it would be difficult. **A motion was made to cancel the Christmas Eve night service this year. There was a second. There was no further discussion. All were in favor. The motion passed.**

Unfinished Business: Pastor Nominating Committee Report

Keith gave the report. He explained that Rev. Dr. Barbara Edema has decided to withdraw as a possible candidate because of the hospitalization of Rev. Jenkins at the First Presbyterian Church in downtown Lansing. Her husband is a member there and this is the church where they attend. She has been called upon to help them in their time of crisis.

Another candidate is John Curphey, who retired from the ministry in June. He is looking for a part-time position. He has preached once in our church and served communion. He is from the Chicago area. He is in the process of setting up his own psychotherapy business and is an artist. He would only like to preach three Sundays a month. He and his wife live in Grand Rapids.

The other candidate is Rev. David Veldt, who is the son of Rev. Mark Veldt. Pastor Bruce had scheduled Mark for three pulpit supply Sundays. Mark received a call from a church in downtown Grand Rapids. David is presently employed as a chaplain in a care facility in Muskegon. He was married in June and lives in Grand Rapids. He will need health insurance. At this time, David is the candidate that best meets our needs. Keith has contacted him, and he responded to Keith's text that he would call him. As of our meeting, he has not heard back from him. It is the recommendation that we see what we can work out with him. **A motion was made for the session/PNC to pursue David as our part time pastor. There was a second. There was no further discussion. All were in favor. The motion carried.**

New Business:

The Downtown Development Authority plans to wrap the historic lampposts with fresh garland. The cost is \$20. We have two lampposts in front of the church. One of them has already been sponsored by the new bakery in town.

A motion was made and seconded to contact the DDA, provide the \$20 and have the lamppost wrapped in fresh garland. David Hanson said he would sponsor the lamppost. Margaret will make the arrangements. Thank you David and Sarah Jane. All were in favor. The motion carried.

Approve an elder to attend the December 5 Presbytery meeting in Mason. Margaret and Evelyn volunteered to attend the meeting. **A motion was made and seconded to approve Evelyn, as the voting elder, to attend the December 5 Presbytery meeting in Mason. There was a second. All were in favor. The motion carried.**
